FINISHED PRODUCT SPECIFICATION

Overview

- a. Product is prepared using sound, washed and sorted organic butternut squash that have peel, fiber and seeds removed. The peeled squash is trimmed, diced, blanched, disinfected, inspected and individually quick frozen.
- b. Flavor and odor should be characteristic of butternut squash with a mild, sweet flavor without any unusual or objectionable odors or flavors.
- c. Frozen diced pieces are free flowing

Ingredient listing: Organic Butternut Squash (no ingredients added)

Physical Properties

Color:

- Uniform, bright color, free from discoloration from oxidation.
- Typical orange of butternut squash

Size:

- Dimensions are +/- 1/8 inch
- May vary due to variations in squash shape; the overall appearance is not seriously affected by units of abnormal size and shape.
- A limited number (10%) of pieces weighing less than 1/10 ounce.

Defects:

- Reasonably free of particles of peel, fibrous pieces and seeds; the overall appearance is not seriously affected by the presence of defects
- Maximum 2 seeds in a one pound sample
- No more than 8% by weight of units with minor blemishes.

Chemical Properties

- a. Brix (Refractometer) 6 8 %
 b. % Total Solids 10 15%
 c. pH (Meter) 7.5-8.0
- d. *Allergens*: does not contain any allergens as defined in the Food Allergen Labeling and Consumer Protection Act of 2004 (FALCPA) because the facility does not manufacture any allergens or use processing aids containing allergens.

- c. Cartons are labeled with the product name, lot code, net weight, the USDA organic logo, name & address of the organic certifying agency and Cardinal Foods name and address.
